**1. REGULAR MEMBERS** (dues \$50.00)

To qualify for regular membership, an applicant must be employed on the editorial staff of a newspaper, periodical, wire service, radio, TV, or other newsgathering organization that regularly reports on the White House. The applicant or the newsgathering organization with which the applicant is affiliated must be credentialed by a Congressional Standing Committee. The applicant's principal journalistic assignments must involve White House coverage.

**2. ASSOCIATE MEMBERS** (dues \$50.00)

To qualify for associate membership, an applicant must be employed on the editorial staff of a newspaper, periodical, wire service, radio, TV, or other newsgathering organization that reports on the White House. Associate members may not vote or hold elective office in the Association. Regular members who retire from journalistic assignments involving White House coverage may apply to the Executive Board for associate membership.

\*\*Applicants are required to submit proof of employment in a journalistic capacity, and a copy of current press credentials to qualify for membership.
